- Your name will generate or populate, and your NPN is the number in the Second Column.

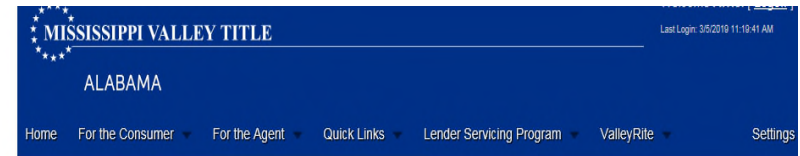
